WELL WATER TESTING DAY







Emergency Watershed Protection Program Update

Since the flood of 2019 on the Middle Fork of Powder River the PRCD has been working to find funding for and complete five Emergency Watershed Protection Projects through the NRCS's EWP Program. These include the stabilization/reinforcement of the 15 Mile Syphon Overflow Structure, the bank stabilization of a part of the Middle Fork of Powder River through the town of Kaycee, and three diversions (Moffet, Gosney & Harlan) on the Middle Fork of Powder River. At this time two of these projects have been completed and the other 3 in various stages of construction.



The 15 Mile Syphon Overflow Structure was a project done in conjunction with the Powder River Irrigation District, the Sahara Ditch Company and the NRCS. Construction began in March of this year and was completed in April. The contractor WyoDak used large

rock to reinforce the overflow structure.



The PRCD worked with the Town of Kaycee, JC Commissioners, WYDOT, private landowners and the NRCS to continue the bank stabilization project that began with the 2016 flood. This project completed the bank stabilization from the HWY 87 bridge east through the Town of Kaycee. This project was constructed by Barnum Inc.

The final three projects are the replacing of three diversions and bank stabilization at the Middle Fork of Powder River located at Moffet, Gosney, and Harlan's. These projects were designed by WWC Engineering and were contracted to Barnum Inc. for construction. At this time the construction of these projects are in the beginning stages and we hope to see completion of these projects by the end of 2021. Due to the scope and size of the projects additional funding sources to supplement the

NRCS's EWP program funds has been secured from the following grant partners: Wyoming Natural Resource Foundation, the Wyoming Wildlife and Natural Resource Trust, Wyoming Game and Fish Department, US Fish and Wildlife Service, and the Resource Legacy Fund. We are extremely thankful to be working with these partners in order to be able to complete projects like these in our community. We are also grateful to our other partners: Private Landowners, Town of Kaycee, JC Commissioners, NRCS, WYDOT, PR Irrigation District, Sahara Ditch Company, Trout Unlimited, and WACD for their continued support of our efforts and willingness to work with the PRCD.



Spruce Budworm Thinning Project Completed

The southern end of the Big Horn Mountain's Douglas Fir population is currently infected by the Western Spruce Budworm. While the WSBW is native to the Big Horns it's current infestation level is high enough it is doing considerable damage to the Douglas Fir population. The District has been working with Wyoming State Forestry to decrease the population to levels that are far less damaging. Currently 67,000 acres of Douglas Fir and mixed-conifer forest are infected by the WSBW and they are causing major defoliation damage in the southern Big Horn Mountains.



With this issue in mind the District applied for a WY State Forestry grant to assist with the thinning of 400 acres of private forested lands and 40 acres of state forested lands. The



district was awarded the grant in the amount of \$130,978, which would pay for the entirety of the project, that included 3 private landowners and a section of state property. The District contracted the project out to Soto Tree Services out of Rapid City, SD. The project got underway in June of 2021 and was completed by the end of August.

While there is till a lot of work to be done to control the WSBW we are very thankful to be able to complete this project this summer and look forward to doing additional thinning projects.

PRCD Attends Regional and Area Meetings

Board Supervisor Kevin Lund and District Manager Anita Bartlett attended the Southwest & Pacific Regional Meeting in Jackson, WY on August 30-31st. Throughout the meeting they discussed natural resource issues that effected the entire region, including: National Water Quality Initiative, public lands, invasive species and much more. As well, there

was considerable discussion on how to market conservation districts to promote the conservation efforts we do in our communities. The conference wrapped up with a tour of a few of the amazing projects that Teton Conservation District has completed.

Kevin and Anita, along with District Conservationist Allison McKenzie, attended the Area I meeting in Dayton, WY. At this meeting attendees were able to tour a RCCP project completed in Dayton that stabilized streambanks that were threatening homes. Along with the tour, attendees were give updates by the NRCS, WY Depart. Of Ag, WY Assoc. of Conservation Districts, and discussed legislative issues that effect the natural resources of Wyoming.
